These facilities, resources and programs have been enhanced and expanded as a direct result of parental voluntary financial contributions. ### **Curriculum Contributions**

Items and activities that students use, or participate in, to access the Curriculum, include:

- Computer applications where our students have their own individual password at Wangaratta High School we use Compass.
- Everyday items that your child will use in the classroom to learn the essential curriculum such as art supplies, science experiment equipment, cooking ingredients, technology materials.

## **Other Contributions**

# **Extra-Curricular (OPTIONAL) Items and Activities**

# Educational items for students to own

Laptop computers are an important part of our schools **Bring Your Own Device (BYOD**) program. # **Financial Support for Families**

Wangaratta High School understands that some families may experience financial difficulty and offers a range of support options, including:

# **FREE INSTRUCTION**

- Schools provide students with free instruction and ensure students have free access to all
  items, activities and services that are used by the school to fulfil the requirements of the
  Curriculum. This includes the Victorian Curriculum F-10, the Victorian Certificate of Education
  (VCE) including the VCE Vocational Major and the Victorian Pathways Certificate.
- Schools may invite parents to make a financial contribution to support the school.

# **PARENT PAYMENT REQUESTS**

Schools can request contributions from parents under three categories:

# Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

# FINANCIAL HELP FOR FAMILIES
