These facilities, resources and programs have been enhanced and expanded as a direct result of parental voluntary financial contributions. This support has led to considerable improvements being carried out, especially in the areas of computer technology, numeracy and literacy support, and through the provision of outstanding resources.

Wangaratta High School staff and students want to thank parents both past and present for their support of the Voluntary Financial Contributions Scheme for the huge difference it makes to our school and the programs we can offer. Curriculum Contributions

Items and activities that students use, or participate in, to access the Curriculum, include:

- Computer applications where our students have their own individual password – at Wangaratta High School we use COMPASS.
- Everyday items that your child will use in the classroom to learn the essential curriculum such as art supplies, science experiment equipment, cooking ingredients, technology materials.

Other Contributions

Non-Curriculum items and activities to support the daily operation and objectives of Wangaratta High School. These contributions contribute towards student wellbeing programs, the purchase of first aid equipment and support the upkeep and improvements of our school grounds.

Tax Deductible Contributions

Tax deductible contributions made per family towards Wangaratta High School.

- Building fund (to support renovations, upgrades, and maintenance of school infrastructure).

Extra-Curricular (OPTIONAL) Items and Activities

Wangaratta High School offers a range of items and activities that enhance and broaden the schooling/educational experience of students and are above and beyond what it could provide if relying solely on Government and Departmental allocations. These are provided on a user-pays basis. Details of these items and activities will be provided to students and families throughout the year.

Educational items for students to own

For some educational items (e.g. devices, stationery, text books), it makes sense for parents to purchase them from a third-party provider, so students can take personal ownership for use at school and/or at home. The school considers the necessity of these items, the cost and preferred suppliers.

Laptop computers are an important part of our schools **Bring Your Own Device (BYOD)** program. Financial Support for Families

Wangaratta High School understands that some families may experience financial difficulty and offers a range of support options, including:

- State Schools' Relief provides financial support for eligible families to purchase clothing/uniforms at a reduced rate

- Any remaining School Saver Bonus funds can now be put towards school activities

Payment methods

PARENT PAYMENTS POLICY OVERVIEW



FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the requirements of the Curriculum. This includes the Victorian Curriculum F-10, the Victorian Certificate of Education (VCE) including the VCE Vocational Major and the Victorian Pathways Certificate.
- Schools may invite parents to make a financial contribution to support the school.



PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
